General:

Covered the seven core objectives of SoBRA.

Membership – this has remained fairly consistent over the last 12 months.

Collaboration continues with various organisations and working groups including the National Land Quality Mark Steering Group (CL:AIRE and SiLC); The National Brownfield Forum (CL:AIRE); JIWG (dormant); (CL:AIRE); Comparing Critical Concentration Guidance (CL:AIRE) AGS; and SAGTA C4SL.

Conferences:

Events – the SoBRA early careers and summer workshop/conference were both postponed due to Covid-19.

Plans are to repeat the SoBRA early careers event in Birmingham and Scotland in 2021.

Plans are to deliver the postponed 'Juggling the emerging contaminant time bomb – understanding changing perceptions of risks? In summer 2021, likely venue of Birmingham.

Accreditation: discussed in detail in subgroup updates to follow AGM. 16% of members are part of the accreditation scheme. January and August windows remain.

Now the scheme is established SoBRA have decided that scrutineers now need to pay annual membership fees (they were previously exempt while the scheme was developed). This will be instigated in 2021.

Finances:

Proposing to set up a new category for research, which would need to be larger than the bursary /scholarship category. In the region of £25,000.
