There have been a few changes to the Executive Committee this year. Olayinka and Jenny both decided to end their term early due to changes in work employment and commitments. Mel Evan's current 3-yr term on the EC also ends at the end of this year. Nomination invitations for the three vacant positions on the EC for 2023 were advertised to members in September and were confirmed at the AGM. Four nominations were received – from Kate Baker of Delta Simons, Mel Evans of Soilfix (standing for a second term), Greg Gibson of Leeds City Council, and Rae Watney of Sheffield City Council. Kate, Mel and Greg were duly elected following the results of the membership vote in October.

Membership

At the last EC meeting held on the 30th August 2022, it was confirmed that SoBRA had 611 members. The figure for last year was 541 so it is fantastic that we have increased our membership over the year.

Finances

According to the audited accounts for the financial year 2021-2022 the society's finances were as follows:

The outcome of the independent audit of the society's finances will be presented at the AGM. This year the audit has again been kindly carried out by Simon Firth of Firth Consultants.

Activities

Since January 2021 the SoBRA Executive Committee has:

- Held 4 committee meetings (all held virtually with the exception of a hybrid meeting in Hydrock's Birmingham office on 30th August) – 19th January, 30th March, 5th July and 30th August
- Organised a successful summer workshop (held at the Priory Rooms in Birmingham on 22nd June): "The Climate Emergency – Practical Considerations for Brownfield Risk Assessment". The event was to be a hybrid event but the online part had to be cancelled due to lack of online ticket sales. Event proceeded as an in person event only.
- Held two accreditation scheme application windows (January and August). There were 14 applicants in total, 12 applying for RSoBRA and 2 applying for ASoBRA. Accrediation was awarded to 11 of the applicants (9 for RSoBRA and 2 for ASoBRA).
- Organised the December conference jointly with the RSC Toxicology Group and the AGM
- Represented SoBRA at the National Brownfield Forum and NQMS steering group meetings
- Maintained collaborative working with other industry organisations by ongoing collaboration with RemSoc, supporting the Energy Institute in various projects by participating in El Soil Waste and Groundwater Group meetings, and presenting on the Controlled Waters and Climate Change publication at various events.
- The early careers sub-group has held six new early careers webinars in 2022 in association with the Scottish Contaminated Land Forum. These have been on an Introduction to Human Health GAC, an Introduction to GAC, Ground Gas Monitoring, NAPL Diagnostic Gauge Plots, Choosing Laboratory Analysis Methods, Foundation Works Risk Assessment, and Introduction to the RTM Worksheet. The webinars are free to members and non-members and the recordings of these webinars are freely available on the SoBRA website https://sobra.org.uk/resources/early-careers-webinars/.
- Agreed to fund a post-doctorate research project at the University of Greenwich on NAPL mobility to support the work of the NAPL sub-group. Work due to start in January 2023.

The society will also continue to progress the accreditation scheme since this underpins the objective to improve the quality of risk assessments, and I look forward to the outputs from the sub-groups in the coming year.

It is a huge privilege to have chaired this society for the past two years, and thanks to everyone's efforts I think that SoBRA is a society that we can all be proud of.
