- There have been a few changes to the Executive Committee this year. Aliyssa Glen stepped down early for maternity leave.
- Nomination invitations for the four seats on the EC for 2024 (for a three-year term) were advertised to members in September and were confirmed at the AGM. Six nominations were received from Sarah Bannon, Stephanie Cox, Rachel Dewhurst (restanding), Melanie Lyons, Tim Rolfe (re-standing), and Kirsty Tolley.
- Sarah Bannon, Rachel Dewhurst (re-standing), Melanie Lyons and Tim Rolfe (restanding were duly elected following the results of the membership vote in October/November.

Membership

We currently have 633 members, up from 611 the previous year.

Finances

The outcome of the independent audit of the society's finances will be presented at the AGM. This year the audit has again been kindly carried out by Sarah Bannon of Ramboll.

Activities

Since January 2023 the SoBRA Executive Committee has:

- Held four committee meetings January, April, July and September
- Held two Accreditation Scheme application windows (January and August). There were 24 applicants in total
- Organised the December 2023 conference jointly with the RSC Toxicology Group and held the SoBRA AGM
- Represented SoBRA at the National Brownfield Forum, NQMS steering group meetings and the recently reconvened Scottish Contaminated Land Advisory Group (SCLAG)
- Maintained collaborative working with other industry organisations by ongoing collaboration with RemSoc, and presenting at various events.
- The Early Careers sub-group has held six webinars in 2023 in association with the Scottish Contaminated Land Forum who provide use of the GoToWebinar platform.
